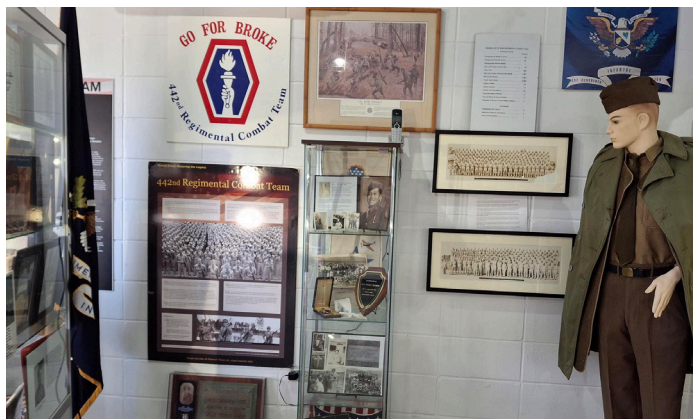

2025 DOD Legislative Proposal for OVS

The Office of Veterans' Services (OVS) is trying to establish a Veterans Cemeteries Board, composed of representatives from the state and county departments and agencies. The board will provide veterans cemeteries in the State with guidance, education, technical assistance and other support to ensure compliance with standards set by the National Cemetery Administration of the United States Dept. of Veterans Affairs.

OVS is responsible for all state veteran cemeteries; however, the OVS Director does not have authority for the establishment and maintenance of those cemeteries. Per §363-5, County Councils are responsible

for the burial of service members, veterans and their dependents. The councils of the counties of Hawai'i, Kaua'i and Maui shall each provide for the establishment of the veterans cemetery or cemeteries to be located within their respective counties, which includes grading, filling, leveling, platting, paving of roadways and walks, installation of curbs, building of fences, planting of grass, trees and shrubs, erection of memorial buildings and monuments, and building of other necessary or convenient structures, and shall make provisions for the maintenance and upkeep of the cemetery or cemeteries.

Update on the Maui State Veterans Home

Tommy Driskoll, VA Home RFP and Certification Specialist, gave a statement on the Maui State Veterans Home.

“The Adjutant General (TAG), Department of Defense, State of Hawai'i, submitted a budget request for a \$35M State Veterans Home (SVH) Maui State Match to the Governor for inclusion in his budget submission to the 2025 Hawai'i Legislative Session. It's my pleasure to report that the Governor has approved our request and is including our \$35M State Match in his new proposed budget.

This is extremely important because a “certified” \$35M State Match is the key to unlocking a Federal \$58M



Match for construction of this new facility on Maui.

Once our \$35M State Match is approved, we will then follow up with completion of other key components of the SVH Construction Grant Application process including 100% facility design, land environmental assessment Phase 1 and a land historic preservation assessment. Our goal is to have these remaining application elements finished and submitted by Aug. 1, 2026 with full funding approval eligibility anticipated by Oct/Nov 2026 thus moving our new Maui project up the SVH Construction Grant funding queue ready to accept the Federal \$58M Match as soon as the funds are appropriated.”
